### **Important Instructions and Standardized Scoring**

#### **Scope of activities**

The activities to be considered for this award are primarily those conducted by the society and not those by individual members of the society.

#### **Eligibility**

**A society that is awarded the award for two consecutive years will not be eligible to apply for the prize a third year in succession.**

#### **Judging**

The judges will be the FOGSI President and preceding 4 past Presidents

#### **Total scoring out of 100 marks**

Classification into two sections – General and Specific

##### **General activities section**

Inclusion of issue as a part of regular society activities and activities with FOGSI

##### **Specific activities section**

Special effort and activities addressing issue

Each section having 5 parts to be given equal weightage

Each part has 10 marks assigned to it

Scoring of each part based on subjective judgment and objective parameters
